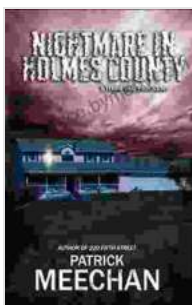


Nightmare In Holmes County: The Terrifying True Story

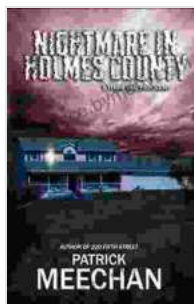
